HOW TO CREATE A CELL PHONE APP TO ACCESS THE VAGABOND WEBSITE QUICKLY AND EASILY

For an iPhone:

- Go to the Vagabond website by entering www.VagabondSkiClub.com.
- At bottom of the page in the shaded line, find the box with an upward-pointing arrow.
- Touch that image and scroll to the right until you see the icon that says: "Add to Home Screen" and click on it.
- Near the top of next screen is an "x", click on the "x" until all words are removed from that line.
- Then enter Vag Website.
- Touch the word "Add" on the top right, in blue.
- Look at your home page and press your new Vag Website app to go directly to the Vagabond Website.




